### BEER TRAILER RENTAL AGREEMENT AND CONDITIONS

- 1. Condition and Return** – Renter is required to pickup and drop off the trailer to Banks Sunset Park Association located at 12765 NW Main Street, Banks, OR 97106 on the agreed upon date indicated in this agreement. The trailer must be returned in the same state in which it was received, except for ordinary wear. Any service or repair to the trailer during the rental period must be authorized by a Sunset Park representative prior.
- 2. Responsibility for Damage or Loss; Reporting to Police** – The renter is responsible for all damage to, loss, or theft of the trailer, during the rental period. This includes cost of repair or the actual retail cash value of the trailer if it not repairable or if we elect not to repair it, loss of use, diminished value of the trailer caused by damage to it or repair of it, missing equipment, and a reasonable charge to cover our administrative and labor expenses connected with any damage claim. Renter must report all accidents involving the trailer to us, and the police within 24 hours of occurrence and provide police report or incident number to us.
- 3. Insurance** – If the equipment is transported (delivered) by us, any incidents and/or damage en-route, and/or during setup, will be assumed by Banks Sunset Park Association, Inc. If transported by the renter or appointee of the renter any incidents and/or damage en-route, and/or during setup, will be assumed by the renter and/or renters' insurer. Renter will also be required to provide a copy of proof of insurance.
- 4. Deposit** – A deposit of \$200.00 will be required on each rental period. We may use renter's deposit to pay monies owed to us under this agreement.
- 5. Charges** – Renter agrees to pay us on demand for all charges due to us under this agreement, including, but not limited to:
  - A.** Time for the period during which renter keeps the trailer, Rental is \$150.00 per day.

- B. Charges for optional services
- C. All traffic, parking violations, fines, penalties, citations, towing charges and other expenses involving the trailer.
- D. A reasonable fee not to exceed \$100.00 to clean the trailer, if returned substantially less clean than when rented.
- E. No refund of rental fees if trailer is returned earlier than date or time due in.

**Prohibited Uses** – The following acts or uses of the trailer are prohibited:

1. Towing of the trailer by anyone not authorized by this agreement
2. By anyone under the influence of alcohol or drugs
3. Trailer is not to be used to transport kegs to and from any location, it's only intended use is to keep beer chilled and to pour from.
4. The max keg storage capacity is 10
5. Trailer can not leave the state
6. When loaded beyond capacity, as determined by the manufacturer
7. In a manner that causes damage to the trailer due to inadequately securing cargo
8. Damaging the trailer by renters intentional, willful or reckless conduct
